SUBJECT: Notification of CBP Proposed Undertaking – Improvement of Roads in Laredo,

Texas

#### Dear Chairman Barcena:

U.S. Customs and Border Protection (CBP) is writing to notify you of a proposed undertaking involving the improvement of roads in the United States Border Patrol (USBP) Laredo Sector in Webb County, Texas.

# **Description of Undertaking**

The proposed undertaking would involve the improvement of approximately 17 miles of roads in USBP Laredo in Webb County, Texas. The existing roads would be converted to Functional Class-2 (FC-2) all-weather roads. A FC-2 road is a two-lane 24-foot wide, unpaved, all-weather road consisting of a surface of imported aggregate material such as milled bituminous material or processed stone and gravel. Maps of the areas of proposed undertaking are included in an attachment to this letter.

#### **Area of Potential Effects**

Pursuant to National Historic Preservation Act regulations, 36 C.F.R § 800.4(a)(1) and 800.16(d), the proposed Area of Potential Effects (APE) for both above-ground and belowground and historic or cultural resources is approximately 15 miles long and 50 feet wide. Ground disturbance would be required along the entire length of the road.

### **Identification and Evaluation of Historic Resources**

Through prior cultural resources surveys and a review of cultural resource studies, there are 10 historic or cultural resources or potentially eligible sites for inclusion on the National Register of Historic Places (NRHP) that have been identified in the proposed APE:
