Furthermore, we acknowledge that it can be, as NCAI states, a "difficult and sensitive issue" as people may have strong emotional and financial attachment for a team and its name/logo/mascot. Some organizations or schools may even mistake support of an individual member for their Native team name, logo, or mascot as likewise support from the whole tribe. It is also possible that when a sports-related depiction represents a particular tribe, the tribe may choose to work with the sponsoring organization to develop or maintain a respectful representation. So, we take into consideration individual opinions of members that may at times differ from our stance or where they work with the organization to maintain respect. Ultimately, though, we oppose any offensive or derogatory image or portrayal that "degrade, slander, mock, or belittle Native people."
